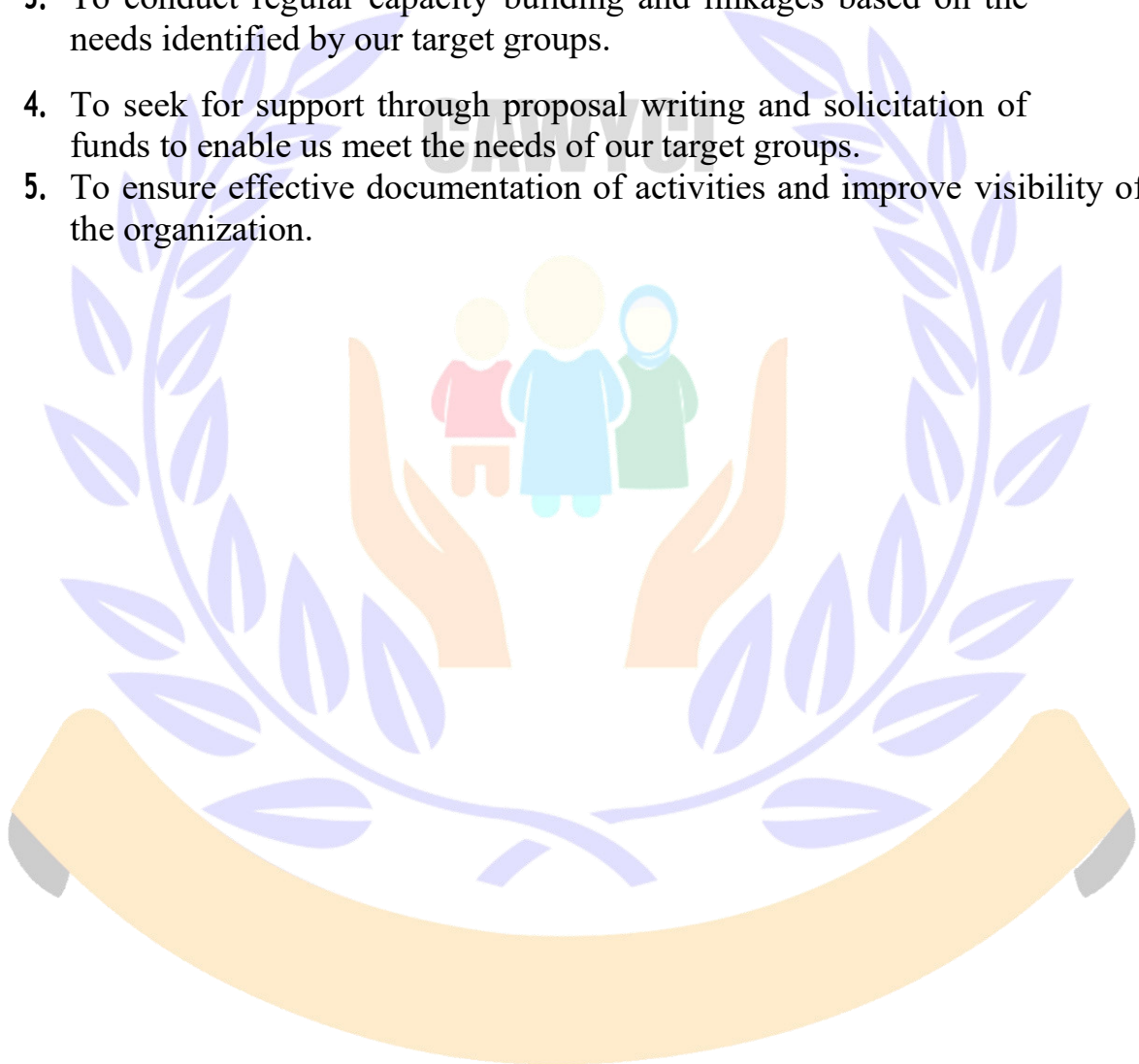

Previous activities conducted

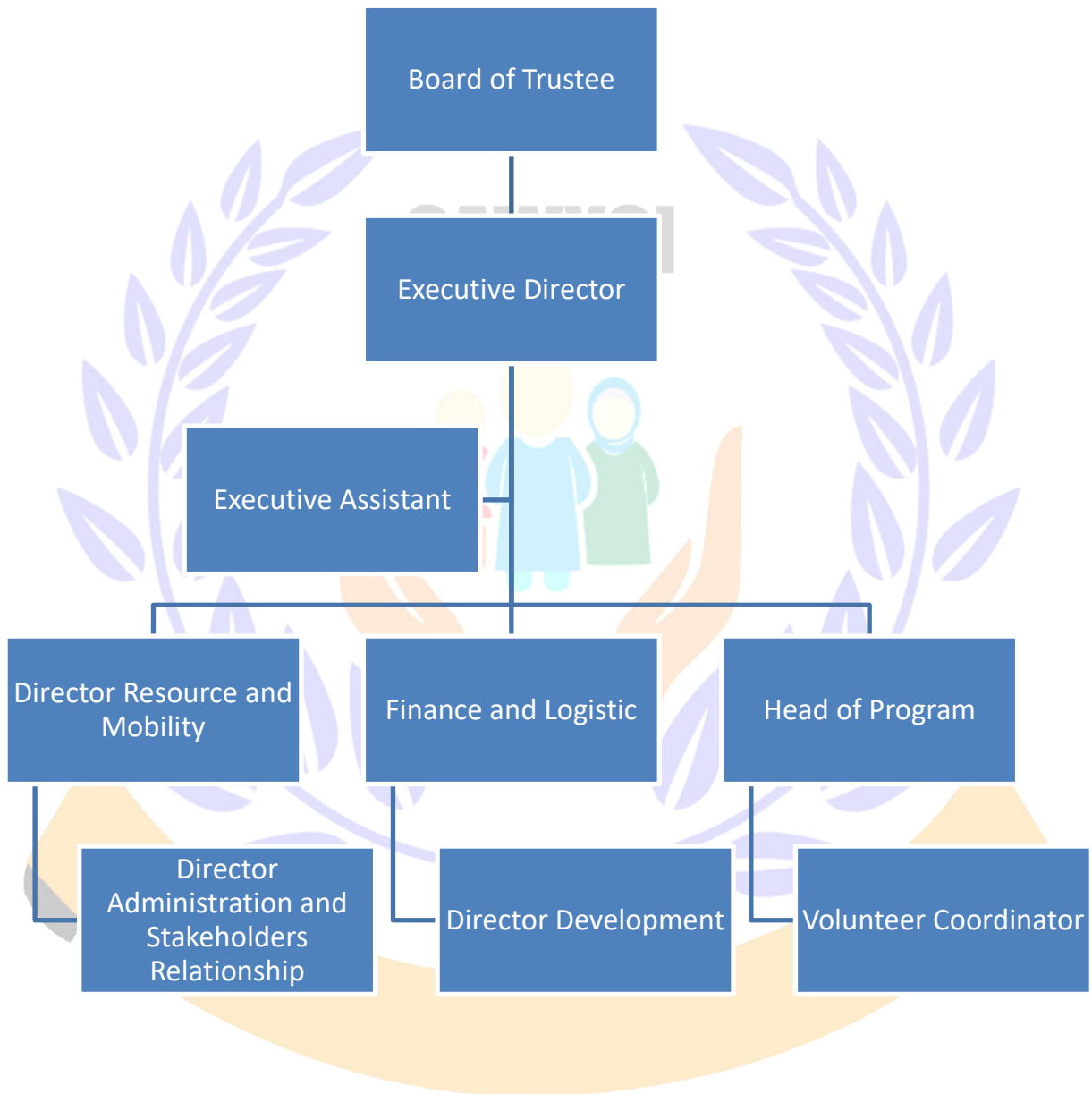

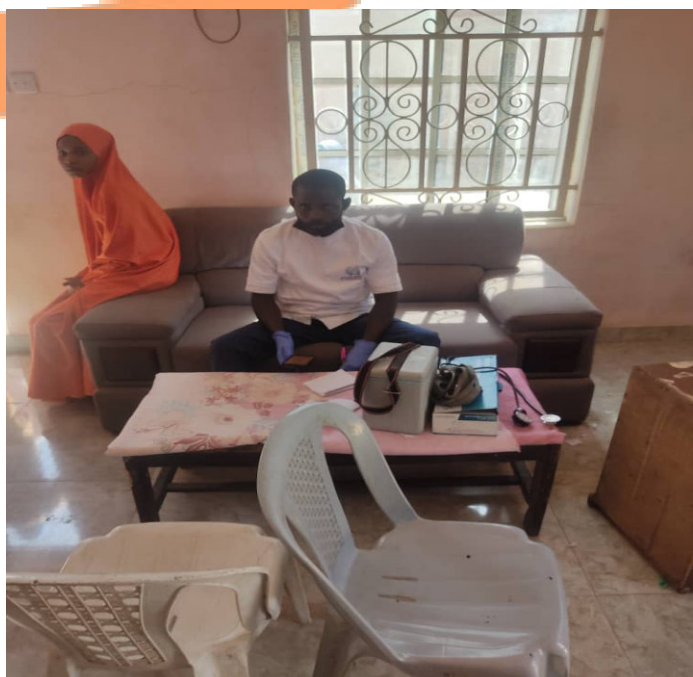
